If there is a balance on the puppy then the remaining balance for the puppy is due NLT 10 days before transfer of Puppy to Buyer.

Please read this Purchase Agreement completely before putting a deposit on a puppy. **By putting a deposit on a puppy, you are agreeing to the terms and conditions within this Purchase Agreement. Blue Hill Toy Aussies** requires a cash deposit to hold the puppy of your choice.

Due to the natural maturing process, puppies are not guaranteed for size or eye color. Breeder exercises best effort to represent estimated size and final eye color.

#### **HEALTH GUARANTEE**

All puppies come with a 1-year health guarantee against genetic diseases, this only applies to the original purchaser. This does not include communicable diseases (Parvo, Distemper, Internal/External Parasites, Heartworms, Kennel cough, Giardia or Coccidia). <u>Blue Hill Toy Aussies</u> warranties this puppy to be free from genetic defects that such as, HC, PRA, DM and others, as hip dysplasia, deafness, serious eye defect that would prevent the puppy from being a companion animal. If puppy is found to have any such defect, written verification from a licensed veterinarian is required. In the unlikely event, verification would need to come from a veterinarian that is board certified in the area of expertise, i.e. genetic eye deformity then written verification must come from a Board-Certified Veterinary Ophthalmologist. If such a defect is found, then a replacement puppy will be given at the Seller's discretion.

- Genetic testing: When our dogs are genetically tested, they are tested by certified genetics testing laboratory. We have dogs that are clear through parentage and are not tested. Genetic testing may have been done on the Puppy being purchased. However, any existing genetic results of the puppies/parents/grandparents are available upon request. If the puppy is a carrier of genetic markers it will be identified in this agreement.
- 2. Each puppy is given a health exam by our veterinarian prior to going to their new home.
- 3. Each puppy is healthy and of sound condition at the time of sale.
- 4. Buyer has 1 week to have the puppy examined by a licensed veterinarian for general health from date of arrival. Buyer agrees to notify Seller within 48 hours of that examination if puppy does not pass general health exam.



5. Buyer should have a licensed veterinarian administer remaining vaccinations needed to protect puppy from disease. Puppy Parvo and distemper vaccines must be given at intervals following first vaccines given by our veterinarian. The suggested vaccination schedule is below, however consulting your vet for proper vaccinations is highly recommended.

- 6. Seller (<u>Blue Hill Toy Aussies</u>) is not financially responsible for the puppy once it departs for its new home. That being said we are always willing to help out whenever we can. Please call us immediately with any concerns.
- 7. Seller cannot be responsible for Hypoglycemia (low blood sugar) or the effects of any stress related illness due to travel/rehoming. For any puppy who is shipped: It is important to offer water and a small amount of food as soon as you get your puppy.
- 8. At no time will the Seller be responsible or obligated to pay for Veterinary Treatments not agreed upon <u>IN ADVANCE</u> and annotated in this contract, including any such expenses directly or indirectly related to any inheritable/genetic defects.

#### **TEMPERAMENT**

- Seller requires the buyer of <u>Pet Quality</u> puppies, to alter puppy between 6 and 12 months of age or based upon your vet's recommendations. Provide a copy of your Veterinary certificate of sterilization and Blue Hill Toy Aussies will rebate you \$100.00. This offer expires 1 year after delivery of puppy.
- 2. Seller strongly recommends that Buyer attend obedience classes with Puppy and provide proper socialization opportunities for the Puppy.
- Seller shall <u>not</u> be held responsible for acts of Puppy destruction, or any Puppy acts, and/or dog/dog actions, dog/cat actions as these are the buyer responsibilities once the pup leaves the seller's home, and any acts/actions which are due to Buyers negligence. Initial here\_\_\_\_\_

#### <u>GENERAL</u>

1. Purchaser is aware that all deposits are non-refundable for any reason. Deposits can only be transferred, if you choose a different available puppy prior to evaluations @ 7 weeks.

- 3. All puppies are sold as show/breed prospect, or pet quality without breeding rights, this does not mean they are, or are not show/breed quality. It only means that until a puppy is fully mature they are a show/breed prospect.
- 4. Males are guaranteed to have 2 testicles descended unless priced as "Pet Only"
- 5. Should Buyer choose to break any of the above portions of this agreement, the remainder of seller's guarantee will be considered null and void.

If you are buying a breeding prospect from Blue Hill Toy Aussies, our expectations are that you only breed the dog with another purebred Australian Shepherd. We do not and will not support a program that produces crossbred dogs.
